TERMS OF SERVICE

1. Spanish Connect Translations guarantees complete confidentiality regarding the client's personal and/or business information.
2. At the beginning of the cooperation between Spanish Connect Translations and the client, I, Beverly Zayas Hayes, will issue a free, non-binding quote for the client. No project work will be started until the client has approved the quote via email.
3. Approval of the price quote via email shall constitute a binding contract.
4. Spanish Connect Translations shall return the translation by the agreed deadline. I shall notify the client immediately if unforeseen circumstances might prevent a timely delivery.
5. Please be advised that translation projects for new clients will require pre-payment. For invoices up to \$300, pre-payment is expected in full. For invoices exceeding \$300, a percentage of the total invoice will be billed in advance.
6. Otherwise, payment is required within 30 days from the date of invoice. Any invoices not paid within 30 days may be subject to penalties. Payment may be made via PayPal, Stripe, wire transfer, or direct deposit.
7. The client shall notify Spanish Connect Translations of any correction requests or changes within 30 days. I shall correct, at no cost to the client, any errors within this time frame.
8. Should the client cancel or withdraw the assignment prior to its completion, Spanish Connect Translations must be compensated for the percentage of total services performed.
